Additional Information

1. World Handicap System

From 2nd November 2020 England Golf moved golf clubs under its jurisdiction onto the World Handicap System (WHS). To operate this system, Bellingham Golf Club must ensure every golfing member's Date of Birth and email address is recorded on the Club's handicapping software. We recommend all members read the Privacy Policy produced by England Golf which explains what purposes this data will be used for.

2. Affiliation fees

Includes England Golf (All categories) and Northumberland Men's (NUGC) or Ladies (NLPGA) Affiliation Fees.

3. Legal Status

Bellingham Golf Club is an unincorporated association without limited liability.

The objects of the Club are:

- 1 To provide facilities for the playing of golf
- 2 To provide facilities for such other amenities as the Board of Management shall from time to time consider desirable.
- 3 The Club is a non-profit making organisation. All profit and surpluses will be used to maintain or improve the Club's facilities or to defray outstanding liabilities.

4. All members of Bellingham Golf Club should be aware of the following:

'A member wishing to terminate his or her membership of the Club shall give notice in writing to the Secretary on or before 31st October otherwise he/she will be liable for the succeeding year's subscription.'
